## KERN COUNTY VETERANS STAND DOWN







Kern County celebrated its 14th Annual Veterans Stand Down and Resource Day on October 11, 2012 at Bakersfield's Stramler Park. The day-long social services resource fair is sponsored by the California Veterans Assistance Foundation, through private donations and grants through the U.S. Department of Labor and the California Department of Veterans Affairs.

It is the second year in a row that CVAF has been at the helm of this event, which is popular among veterans – many of whom are homeless. The biggest draw to this event every year is Veterans Court, where veterans with Kern County misdemeanor fines and traffic tickets are able to get them cleared with community service.

This year, 329 veterans and 28 dependents were in attendance. The CVAF Board of

Directors (Robert Piaro, Tim Maples and Michael Hikel) manned the registration booth with help from Hill Reyes, Marlia Maples and CVAF staff Nancy Price and Rosemary Hobbs. According to Rosemary, "I had a great time working registration with the Board. Everyone worked as a team to make it a supportive environment for veterans who were attending the event."

Over 40 service providers were in attendance offering haircuts, massage therapy, backpacks, employment and housing assistance, benefits counseling, flu shots, medical screening, VA enrollment, mental health counseling, burial benefits, legal assistance, ID cards, food baskets, pet food, two hot meals and lots of camaraderie.

Next year's Stand Down date has already been set. It will be October 10, 2013.

# SUPPORTIVE SERVICES FOR VETERAN FAMILIES NOW AVAILABLE

Supportive Services for Veteran Families (SSVF) is beginning in October! The SSVF Program promotes housing stability among very low-income Veteran families who are homeless and those who reside in, or are transitioning to, permanent housing. This is a new program operating under the auspices of CVAF. It will allow CVAF to provide services to 70 veterans and their families.

A point-in-time survey in 2011 showed that more than 67,000 veterans were homeless at that time. However, there is hope. The incidence of Veteran homelessness has fallen twelve percent since 2010. Veterans who are in danger of losing rental housing (Homeless Prevention) OR homeless Veterans in need of rental housing (Rapid Re-housing) AND very low income may be eligible.

This quarter has been fast, furious and fabulous! It seems the first half of the year I spent grant writing, and now that they have been awarded, we are work-

ing hard at getting them established.

Between October 2011 and October 2012, CVAF has procured close to \$800,000 in grants for homeless veteran housing and supportive services, including:

- \$271,000 in U.S. Department of Housing and Urban Development Continuum of Care funding for permanent supportive housing;
- \$122,000 in U.S. Department of Labor

funding for job training and community reintegration;

- \$180,000 in U.S. Department of Veterans Affairs funding for Supportive Services for Veteran Families a sort of Homeless Prevention and Rapid Re-Housing Program for vets; and
- \$213,000 in U.S. Department of Veterans Affairs funding for "Transition in Place" and transitional to permanent supportive housing program.

With expanding services, CVAF purchased a new administrative office that houses Heather Kimmel, Caroline Two-Cats Romero and me. Attached to the office is an 800 square foot warehouse that we utilize for a donation drop off site. The National Coali-

tion for Homeless Veterans and The Home Depot Foundation hosted a Housing Summit in San Antonio in September. It featured two full days of targeted training sessions, intensive workshops and opportunities for engagement with critical partners involved in expanding the availability of permanent housing options for homeless and at-risk veterans and their families.

Last, but not least, we just wrapped up the Kern County Veterans Stand Down on October 11th. I would like to extend my sincere thanks to all of the people that helped make this year's Stand Down a great success. This event truly belongs to the veterans of Kern County and it is an honor to be of service.

## **HOME FIRST 12 PROGRAM**

As CVAF continues to partner with the Kern County Homeless Collaborative (KCHC) and their efforts to end homelessness in Kern County, new opportunities to help continue to arise. In the last year, the KCHC launched the 100,000 homes campaign with a program called Home First 12 (HF12). This program focuses on housing the 12 most vulnerable and chronically homeless individuals in our community who, without this assistance, would likely die on the streets. CVAF committed to case manage three individuals through this program.

Step one of the HF12 process was to identify these individuals by hitting the streets to conduct a survey. After the surveys were collected, the information was compiled into a database that identified

the twelve most vulnerable individuals. The KCHC then gave the participating agencies the names of the individuals they were to case manage.

This program is a housing first model, which means the client is placed into housing as quickly as possible before services begin. Once their housing is stabilized, an intensive case management approach is implemented with wrap around services. CVAF is proud to say that we have successfully housed two clients. Executive Director Heather Kimmel states, "Their move in day was emotional. You felt the sense of relief that, for once, housing was no longer a concern. The realization that finally everything was going to be alright. We are so proud of our HF12 clients, and continue to be the cheerleader in their corner."

# **LEARNING THE ROPES!**



Expanding available programs for homeless veterans in Bakersfield remains a top priority for the California Veterans Assistance Foundation. In the last year the organization has been awarded four new federal grants

to develop programs from employment and retraining to permanent supportive housing and homeless prevention. In developing so many new programs, CVAF staff realized that they had a lot to learn. So, when you have questions, who do you ask?

You go to people who have experience, expertise and have been successful

at what they do. That is exactly why Executive Director Heather Kimmel spent a week with the nationally recognized program U.S. Vets. During her week long training in Las Vegas, she learned the ins and outs of one of CVAF's new programs called Supportive Services for Veterans Families (SSVF). With this program, CVAF hopes to assist 70 veteran families in Kern County with homeless prevention assistance and rapid re-housing. Heather Kimmel shares her thoughts on the new program: "We will be able to step in and help people before it gets to the point of homelessness. We have an experienced case management staff that will be able to assess the veteran's needs and link them to the resources to help them become stable in housing."

# JOBS DEVELOPMENT CORNER



CVAF is happy to announce that we received a grant through the U.S. Department of Labor, Homeless Veterans Reintegration Program (HVRP) to

provide services to assist in reintegrating homeless veterans into meaningful employment within the labor force. Ron Hernandez is our Job Developer for this program and we are coordinating several training programs to include power, wind and solar technology, truck driving, Certified Nursing Assistance training, OJT, Guard Card certification, as well as helping veterans with barriers to employment

# HIGHLIGHT A VETERAN



Manuel V.

My name is Manuel V. I am a U.S. ARMY (82nd Airborne Division) veteran and I entered The California Veterans Assistance Foundation (CVAF) on July 24, 2012.

Before coming to

CVAF, I was fighting homelessness and an addiction with methamphetamines. I had severe emotional problems and was on the verge of losing everything I had been working for. Also before I came to CVAF, I was an angry person and I couldn't make sense of my life. Since I've came to CVAF, all that has changed. I am no longer an angry person. I don't have urges to use drugs. I have truly learned my lesson from this final relapse. I have learned to take charge of my life, which includes noticing that I was being selfish in the past.

I have three children (Serrena, Sierra

and Allen) that need me. I have learned while being at CVAF that I affect people, children included. When I succeed, my children benefit from my success and when I fail because of bad choices, my kids suffer from my failures.

Things are really moving forward in my life now. I am a resident manager here at CVAF; I have a job at NRG Energy as an executive assistant. I am planning to finish up my bachelor's degree at California State University. Bakersfield (CSUB) in January through VA benefit chapter 31. I attend Narcotics Anonymous (NA) meetings and I go to church to take care of my spiritual health. I have a great support group, which includes all the staff here at CVAF. Each one of them has played a part in my success. There are things that I haven't accomplished yet, but I believe that as long as I continue to apply the things that I have learned here, my life will be a whole lot better.



Michael J.

My name is Michael and I am a veteran of 14 years of active duty service in the U.S Navy. After discharge from the military, I became incarcerated in the state of

Virginia. After my release, I returned to California to serve my probation and look for work. I moved back in with my family, but my return caused them a lot of burden, so I had to seek employment in another county, putting me in a homeless situation.

I mentioned during a NA meeting that I was seeking work and looking for a drug/alcohol free place to live. A fellow veteran told me of the California Veterans Assistance Foundation and that their program would help me with both housing and employment.

I am now working for Caterpillar and housed in a clean drug/alcohol free home at the Decatur location. The program is helping me with personal needs in a positive environment that will help me in my transition to standard living.

obtain birth certificates, driver's licenses and work clothing.

An array of services utilizing a case management approach directly assists homeless veterans, as well as providing critical linkages for a variety of supportive services available in their local communities. The program is employment focused, and veterans receive the employment and training services they need in order to re-enter the labor force. Job placement, training, job development and career counseling are some of the services being provided.

According to Ron, "Job development has been in full swing for about three months now and just finished our first quarter for the grant. I am proud to say that everything is going great. During our first quarter, we needed to place eight veterans into work and we managed to get seven employed. We now have a total of 33 veterans enrolled in the program and we are kicking off our second quarter strong with two placed into employment and two in training to be solar technicians. Our goal for this quarter is to have five more placed into work and 22 more enrolled into the HVRP program. I feel as the job developer that these goals should be no problem to meet."

Ron is doing an outstanding job with this position and we will feature veteran's successes in this program in future editions of the Alliance.
